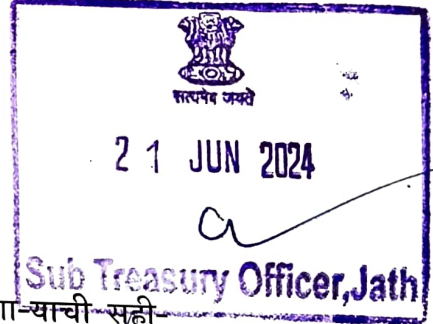

Pursuant to the proposal of the attached organization, please be informed that English medium etc. run by Sangli Mission Society, District Sangli. Alphonsa School, BhosleVasti, English Medium School in Jat which continues till 7th standard etc. 8th to etc. The Government is giving permission to start the 12th class on a permanent non-subsidy basis subject to the following terms and conditions:-

- 1). within one year from the date of the permission order, the institution shall submit the affiliation certificate to the State Board (Provisional and then regular) application will be required.
 - 2). The said permission is required for Road Certificate (Regular Affiliation) issued in the State Government. Subject to fulfilment of all applicable criteria.
 - 3) If the criteria laid down by the State Board for Affiliation Certificate (Regular Affiliation) are not fulfilled, the said permission order shall be considered cancelled.
 - 4) Shifting of the said school from the permitted location will not be allowed.
 - 5) The concerned school shall be bound to follow all orders issued by the Government, Director of Education (Secondary and Higher Secondary), Pune and State Board.
 - 6) Permission granted etc. In classes 8 to 12 it will be necessary to teach the syllabus prescribed by the Maharashtra State Board of Secondary and Higher Secondary Education.
 - 7) All orders in progress in the school at the time of the permission order are hereby permitted.
