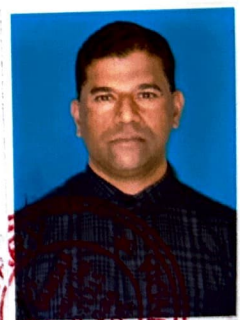

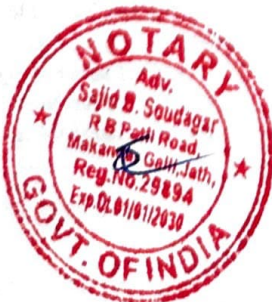

I, the Education Officer (Primary), Z..P. Sangli, hereby grant provisional approval to Alphonsa School, Jat Taluka, Jat Dist. Sangli from class 8<sup>th</sup> onwards for a period of three years from 01/04/2022 to 31/03/2025. The above approval is subject to the fulfilment of the following conditions:-

1. The period of recognition will not be extended and there will be no obligation under any circumstances to grant recognition or affiliation after class VIII.
2. The school shall comply with the provisions of the Free and Compulsory Education Act, 2009 (Annexure One) and the Maharashtra Right of Children to Free and Compulsory Education Rules, 2011 (Annexure Two).
3. The school shall admit children from the weaker sections and needy groups in the first class to the extent of at least 25% of the number of students in that class and shall provide them with free and compulsory education till the completion of primary education, provided further that this standard shall also be followed in the case of pre-primary classes.
4. The school shall be provided with a separate bank account for the purpose of receiving reimbursements in accordance with section 12(2) of the Act for the children referred to in paragraph 3.
5. The institution/school will not charge any capitation fee and will not force the children to submit their parents/guardians for any screening process.
6. No child shall be denied admission to school on any grounds including religion, caste, creed, or place of birth without proof of his/her age.
7. (1) No child admitted to school shall be retained in the same grade in which he is enrolled or shall be expelled from school until he has completed his primary education.  
(China) No child shall be subjected to physical punishment or mental torture.
- (3) Every owner of a vehicle shall be required to pass the examination of any board till the completion of primary education.
- (4) Every person who has completed primary education shall be given a certificate as prescribed in Rule 23.
- (5) Students with disabilities will be included as per the provisions of the Special Needs Students Act.
- (6) The minimum qualification made under section 231 of the Act shall be applicable to teachers holding the minimum qualification, but it shall be applicable to teachers holding the minimum qualification on the date of commencement of the Act and to teachers not yet holding the minimum qualification, who shall be liable to pay at least five
- (7) The teacher shall perform his/her duties as prescribed in section 241 of the Act and
- (8) The school will ensure that the teacher does not engage in private tutoring.

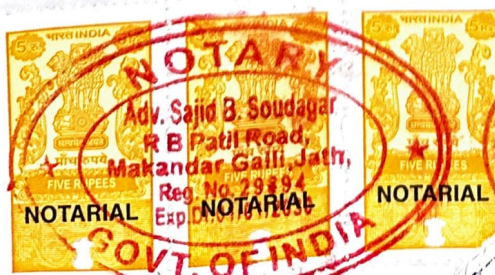

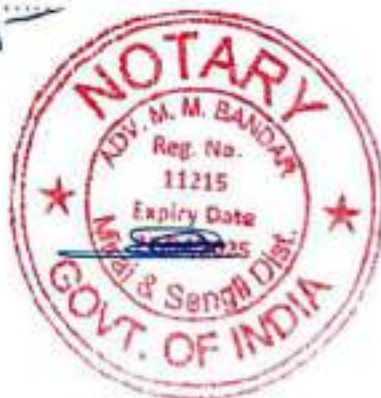
